We have completed an assessment of what we need to do in order to meet the Standards in Section 1, 2 and 6. Section 1 - Governance - We would like to hire a consultant to support us to update our Board governance policies (specifically standards 1.03, 1.04, 1.05, 1.06 and 1.07). We have identified a consultant with the necessary expertise and a detailed proposal is attached.

We require additional staff time to create a business continuity plan (1.10) and to review our volunteer and employee policies (2.01, 2.02, 2.05) to ensure they align with the standards and provincial legislation. We have an existing part time staff person who can take on additional hours to complete these tasks.

In order to meet the food safety standards, we need to:

- purchase a vacuum sealer to meet standard 6.13
- install a new hand-washing sink to meet standard 6.09
